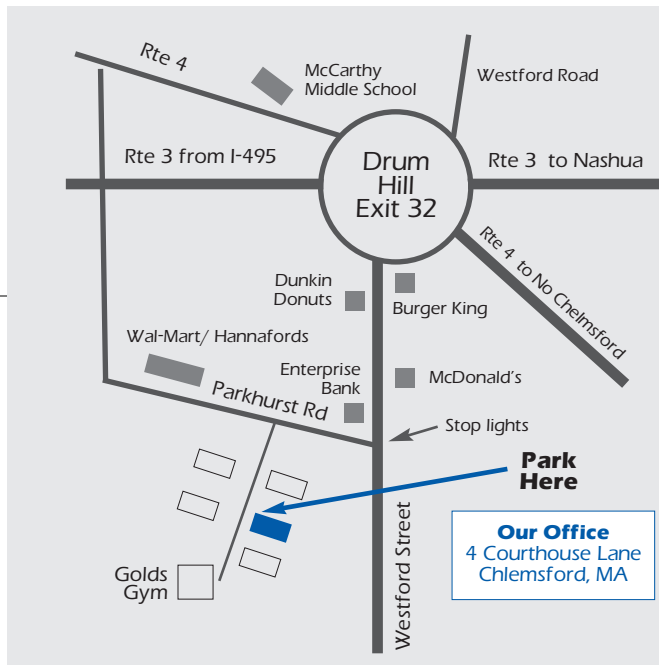

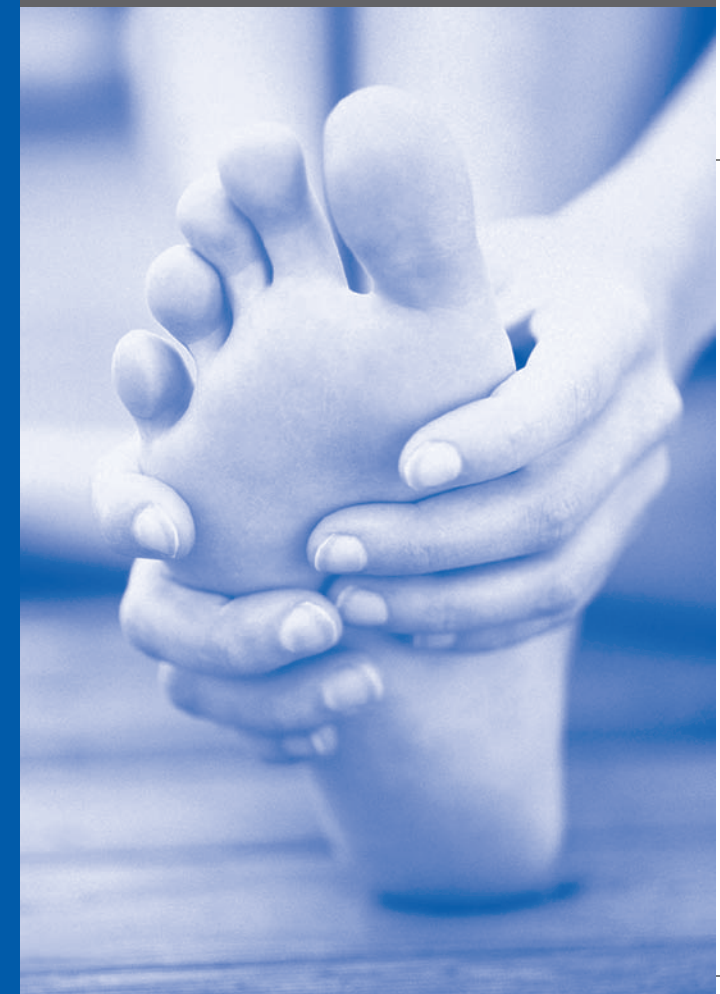

Your Feet Deserve Skilled Care

Many patients tell us they have delayed getting treatment until they cannot stand their pain anymore. Typically, these patients have suffered in silence from bunions (enlarged joint at base of big toe), neuromas (pinched nerve in forefoot), hammertoes, ingrown nails and heel pain. They have delayed seeing a physician because of the imagined inconvenience to their schedule, expecting that the treatment will be uncomfortable, or hoping that the condition will improve with time. But, most often, these conditions do not resolve on their own without professional intervention. After treatment, our patients commend us for our

Appointments

We continue to accept new patients and offer same day visits for emergencies. In an effort to respect our patients' time, we try very hard to stay on schedule. We know you don't like waiting. Because of this, we ask that you come to your appointment on time and we will do our best to stay on time, too. If you are more than 15 minutes late for your appointment, it is possible that we will have to reschedule your appointment.

A lot of time is invested in preparing for your visit and your doctor sets aside time just to see you. We ask that if you are unable to keep your scheduled appointment, please call us 24 hours ahead to reschedule or cancel your appointment.

We treat all types of adult and children's foot problems, stressing preventive care and early medical intervention. Common problems that we treat are:

- Bunions
- Foot & Nail infections
- Ingrown Nails
- Arthritis, Gout
- Heel Pain
- Diabetic Foot Care
- Neuromas (pinched nerves)
- Hammertoes
- Toe joint (implants) replacements (for severe arthritis)
- Emergency lacerations
- Plantar Warts
- Sports-related injuries
- Fractures
- Custom Orthotics
- Children's gait problems (intoe, outtoe)
- Ankle Sprains

Emergency Services

When our office is closed, the covering physician can be reached 24 hours a day, including weekends, for emergencies. You can reach the doctor on call by dialing the office telephone number and getting the doctor's pager number.

Referrals

If your primary care physician has sent you to our office and your health plan requires a "referral", you have the responsibility to communicate with your PCP prior to the appointment to allow for the mailing or faxing of the documentation. If the referral has not been received prior to your visit, you will be held responsible for the cost of the visit.

Billing and Insurance

Our responsibility is to keep accurate records and bill appropriately; your responsibility is to provide us with up-to-date information, pay your co-pays and to know the benefits and limitations of your insurance plan. We are always available to answer your questions about your account. Your insurance company requires that you bring your insurance card with you to each appointment and that you pay your co-pay, which is due at the time of service.

You are welcome to call us to check if we are participating providers with your insurance plan. For contracted insurance plans we will submit claims on your behalf. Otherwise, payment is expected at the time of your appointment. MasterCard and Visa are accepted. Payment for non-covered services, such as supplies, is required at the time of service. You are welcome to call our billing department if you have any questions.
